My research focuses on developing better ways to help people change. Much of this work blends technology, behavioral science, and systems-level implementation to improve health outcomes for underserved and high-risk populations. Recent projects include: 1) designing and testing an adaptive smartphone intervention to reduce alcohol use among adults experiencing homelessness; 2) developing and evaluating a communication skills training for U.S. Army operational units to improve unit cohesion and mental readiness; 3) testing an online vocational training program to support employment among justice-involved veterans; 4) disseminating and implementing strategies to reduce pain, opioid use, and overdose at the community level; and 5) designing, adapting, and scaling substance use interventions for adolescents, young adults, and people with developmental disabilities. Outside of research, I frequently train professionals in motivational interviewing, and in my spare time, I enjoy writing newspaper articles on topics like Ben Franklin, Western movies, and cartoon villains.
